Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

We continue to have dialogues with owners to improve our relations and recruit new ones.</p> <p>PROGRESS REPORT: <i>The PHA has registered 12 newly participating owners in the HCV program last year and is continuing to build positive relationships with existing participating owners. This has been especially challenging since the COVID-19 outbreak and the tension now exist between some Owners and tenants due to unpaid rents and Eviction Moratoriums.</i></p> <p>GOAL: To maintain our High Performer SEMAP Score Status with HUD.</p> <p>OBJECTIVE: The City of Hawthorne Housing Authority shall appropriate report and document all required information to HUD.</p> <p>PROGRESS REPORT: <i>The PHA continues to submit timely reporting of 50058's and all required inspections. MTCS errors are immediately corrected and resubmitted. The agency reviews EIV reports regularly and takes the appropriate action towards resolving any inconsistencies related to date entry, file status, or income discrepancies. The Two Year Tool is updated monthly, and the PIC Drill Down is monitored to ensure awarded funds are appropriately used. The agency continues to function at a High Performer Level.</i></p> <p>GOAL: Improve the quality of assisted housing.</p> <p>OBJECTIVE: Increase customer satisfaction and maintain high quality of service; improve management functions and inspections; Housing staff will attend annual Fair Housing trainings; the City of Hawthorne Housing Authority will continue to provide its staff with necessary trainings to meet job responsibilities and goals.</p>

	<p>PROGRESS REPORT: <i>The PHA is dedicated to providing the best customer service while following all regulations. Staff has used this year to take "Fair Housing" and "How to deal with Difficult People" Training. The goal has been to work hard to avoid any type of backlog even with staggered work from home schedules. Due to COVID-19 and with the CARES Act Administrative funding award, the agency has been able to purchase software to help streamline processes. We are now able to provide convenient contact and follow-up with staff through online access to file status for Owners, Tenants, and Applicants with our new Assistance Connect Program. We have simultaneously begun scanning all files to avoid person-to-person contact. This paperless system allows staff to offer the highest quality service while remaining safe in the wake of this Pandemic.</i></p> <p>GOAL: Ensuring equal opportunity in Housing for all. OBJECTIVE: The City of Hawthorne Housing Authority is providing bi-lingual services to applicants and participants. PROGRESS REPORT: <i>The PHA continues to follow all LEP requirements in adhering to all request from its customers to provide oral and written communication in the preferred language as required. As well as automatically providing Spanish and English versions of our written forms and letters to meet the needs of the demographics of the majority of our diverse population. Our offices are also ADA compliant for all visitors to enjoy the resources we offer.</i></p> <p>GOAL: Expand the total number of families served by the City of Hawthorne under the Section 8 Program. OBJECTIVE: The City of Hawthorne Housing Authority will continue to select from the current Waiting List as many as possible applicants as our limited funding permits. PROGRESS REPORT: <i>The Pandemic has had a significant impact on the HAP assistance provided due to the loss of jobs, including almost spiraling the Housing Authority into Short Fall. We were able to over this obstacle and continue to pull from our Waiting list as vouchers become available through attrition and through close monitoring of HAP payouts to help new families receive assistance. The PHA is still committed to reach 100% utilization.</i></p>

Responses to the collection of information are required to obtain a benefit or to retain a benefit. The information requested does not lend itself to confidentiality.
